Lemtrada is a CD52-directed cytolytic monoclonal antibody indicated for the treatment of relapsing forms of multiple sclerosis (MS), to include relapsing-remitting disease and active secondary progressive disease, in adults. Because of its safety profile, it should generally be reserved for patients who have had an inadequate response to two or more drugs indicated for the treatment of MS. For the same reason, it is not recommended for use in patients with clinically isolated syndrome (CIS). Lemtrada has a black box warning for autoimmune

For *initial* authorization:

- 1. Member must be 17 years of age or older; AND
- 2. Medication must be prescribed by, or in consultation with, a neurologist; AND
- 3. Chart notes have been provided confirming diagnosis of one of the following types of MS:
 - a) Relapsing-remitting with at least 1 relapse in the past year or
 - b) Active secondary progressive; AND
- 4. Member has documentation of at least one of the following:
 - a) Inadequate response to two or more drugs indicated for the treatment of MS
 - b) Highly active disease (aggressive or rapidly evolving) in the expert opinion of the prescriber; AND
- 5. Documentation to show all the following baseline assessments have been or will be completed:
 - a) Complete blood count
 - b) Thyroid function test (e.g., TSH)
 - c) Serum creatinine and urinalysis

For reauthorization:

- 1. Chart notes must document positive clinical response compared to baseline such as fewer relapses or slowed progression of disability; AND
- 2. Twelve months have elapsed since the last treatment course; AND
- 3. Treatment plan for the course of therapy is 12 mg/day on 3 consecutive days (36 mg total) (QL: 3 vials per 365 days)
